Bemidji Jaycees Release and Waiver Liability, Assumption of Risk and Indemnity Agreement

In consideration of participating in the Bemidji Jaycees BRRRmidji Plunge (Activity), (1) I represent that I understand the nature of polar plunging events and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity. (2) I fully understand polar plunging events involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the Activity, the conditions in which the Activity takes place, or the negligence of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and (3) I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity. (4) I hereby release, discharge, and covenant not to sue the Bemidji Jaycees, JCI Minnesota, the City of Bemidji, County of Beltrami, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations; and (5) I further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim. (6) By registering for this Activity, I give my consent and understand that my photo or video may be taken during the Activity. You grant permission to the Bemidji Jaycees and their Official Photographer to use my photo, video, or likeness in any publicity or promotional publications (e.g., website, social media platforms, newspaper ads and/or reports, bulletin boards, newsletters, programs, brochures, public broadcasting releases, etc.) and to allow the news media to film and/or photograph the Event for broadcast purposes. I have signed it freely and without any inducement or assurance of any nature and intend it and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
